The Boulder County Parks & Open Space Department has an opening for a Seasonal Forestry Technician, to perform a variety of skilled and semi-skilled duties in the management of county forests, including fuels reduction, insect and disease management, biomass utilization, and other wood harvesting related operations.

## **EXAMPLES OF DUTIES**

Assists with all forestry operations related tasks, including directional tree felling, skidding, forwarding, processing, and transport of woody biomass through the use of chainsaws, chippers, various forestry related heavy equipment, trucks, and trailers.

## **REQUIRED QUALIFICATIONS**

High school diploma or equivalent and a minimum of one year experience in forestry/logging operations or the arboriculture/tree care industry. Ability to perform manual labor for extended periods of time in a variety of weather conditions and rough terrain.

Preferred Qualifications: Significant experience with chainsaws and tree felling, working knowledge of silviculture and related harvesting systems; ability to maintain and operate forestry related heavy machinery; equipment and mechanical troubleshooting aptitude; Class A or B CDL, or other truck and trailer experience; comfortable working in the woods with minimal supervision; ability to maintain a positive and team oriented attitude.
